Requirements for 2026-2028 available on website now!

The CoreTrustSeal Board has analysed the feedback received from its community on the proposed changes to the requirements for the next three-years period starting in 2026.

It was great to see that there is a general, positive consensus in favour of the revamping - with small adjustments suggested by the respondents to the survey which have mostly been taken into account.

The CoreTrustSeal Documentation Suite (requirements, extended guidance and change log) have been updated accordingly and are now available on our [website](#).

The new requirements will enter into force in January 2026.

Note that the Application Management Tool (AMT) will be closed for **NEW** applications only in November and December 2025.

The International Digital Curation Conference (IDCC) is an established annual event with a unique place in the digital curation community, reaching out to individuals, organisations and institutions across all disciplines and domains involved in curating data and providing an opportunity to get together with like-minded data practitioners to discuss policy and practice. The 20th edition of the IDCC will take place in Zagreb, Croatia between 16-18 February 2026.

Call for nominations - WDS Data Stewardship Award 2026

The World Data System (WDS) is pleased to announce that nominations are now open for the **2026 WDS Data Stewardship Award**. This distinguished recognition celebrates early-career data stewards who have demonstrated:

- Comprehensive data management and/or curation across the full data lifecycle.
- Adherence to legal, policy, and ethical standards.
- Significant contributions to improving the quality, integrity, and accessibility of research data and metadata.

Eligibility:

Nominees should be within 10 years of completing their Master's, PhD, or equivalent professional training. Nominations are welcome from peers, organizations, or as self-nominations.

Selection Process:

A panel of WDS Scientific Committee members, representatives from the International Technology Office, and ECR Network Co-chairs will review submissions based on impact and alignment with open science principles.

Note: Private sector nominees must clearly show community value beyond profit.
