Shorter timelines for applications still running under the 2020-2022 requirements

The timelines for applicants and reviewers have been made shorter. Applicants now have a maximum of 2 months to respond to the reviewer comments. Reviewers have 1 month to respond to the applicants changes. This way we hope to get the applications under the old requirements out of the way as soon as possible.

If it is not possible for the applicant to respond within two months they are offered to be moved to the new requirements form and will get the remainder of the rounds left on their application under [Requirements 2023-2025](#) at no extra costs. Application Management Tool (AMT)

The [Application Management Tool \(AMT\)](#) has been launched in the beginning of February. Unfortunately some bugs came floating to the surface but we have been working very hard to fix them.

Access to the tool: Users of the old tool have to reset their password. This did not always go as planned, but is now sorted! If you are still having problems with accessing the tool please contact info@coretrustseal.org

Data migration issues:

- Applications that need to be revised by the applicant do not have the correct reviewer responses with them (information is missing). The affected applicants have all been contacted via email and sent the correct reviewer data. The secretariat will correct the reviewer data in the tool once a new version is submitted by the applicant.
- The links mentioned in the applications the old tool have not been added to the new tool correctly. Applicants are requested to move their links to the separate field provided in the new tool when resubmitting their application. Review due date: Reviewers did not get the emails informing them of a new submission from applicants and their new review due date. All reviewers have now received the correct emails with the due dates. If you cannot make a review date please contact info@coretrustseal.org and they will change the date to a more convenient time.
